Policies

- I recognize that I may not be accepted into the program. I may also be removed from the program for reasons, such as failure to make payments as schedule, failure to submit required forms and materials in a timely manner, failure to attend pre-departure orientation, failure to obtain travel documents, and failure to disclose information.
- Refunds will be issued as follows:
 - Before August 1, 2016 \$100 penalty
 - Before September 1, 2016 \$500 penalty
 - Before October 1, 2016 \$1000 penalty
 - Before November 1, 2016 \$1500 penalty
 - December 1, 2017 or after **No refund will be issued and full program cost will be billed**
- I recognize that countries have different laws and standards, such as the American Disabilities Act. If accommodation is required, it is my responsibility to submit those in writing upon application.
- Participants are advised to obey local laws. If a participant faces charges, the College is not responsible for legal assistance. The tour group will maintain its schedule and the individual is responsible for reuniting with the group or making her/his own arrangements to return to the United States.
- Participation is limited. If the program is full, applications will be kept and names placed on a waiting list. Available places will be filled as available and will be based on vendor restrictions and timing.
- During the cultural trip, there may be personal time available. Independent activities are at my own risk.
- Although some travel insurance is available, participants should know that countries often require pre-payment for medical care in cash.
- Participants are responsible for all personal expenses associated with the trip, including but not limited to souvenirs, snacks, most meals, etc.
- Participants are expected to represent that college during all travel and activities. Failure to meet behavioral expectations may lead to dismissal from the program. Participants dismissed will be returned to the United States at their own expense. Any expenses incurred as a result of violating behavior expectations will be billed to the participant by the college.
- All refund requests must be made in writing to be eligible for any refunds, according to the schedule above. Carl Sandburg College reserves the right to assume participation and full payment unless or until this written notice is submitted to James Hutchings, Study Abroad coordinator.
- In the event that the trip receives more applications than it has space, applicants will be waitlisted in the order that they are accepted, including application fee. Those who are unable to be accommodated will receive a full refund of the application fee. Those who are accepted later are responsible to meet payment deadlines as outlined above.
- I have read and understand the payment policies, refund schedule, and expectations and understand I am subject to cancellation penalties.
